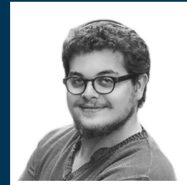

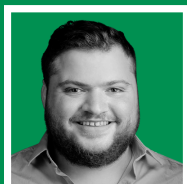

No electronic products leaving Swipe Ice's facility will be directed to incineration, energy recovery or land disposal facilities unless no other reuse or recycling options are viable.

SERI is a non-profit organization that oversees the R2 (Responsible Recycling) standard, which provides guidelines for electronics recyclers to ensure the safe and ethical disposal of electronic equipment.



ISO 14001:2015 specifies the requirements for an environmental management system that an organization can use to enhance its environmental performance. ISO 14001:2015 is intended for use by an organization seeking to manage its environmental responsibilities in a systematic manner that contributes to the environmental pillar of sustainability.
